

# Liberal Votes by Chuck Hall

Seven-year-incumbent Chuck Hall has consistently cast votes that do not align with our values. This flier highlights a small, sample selection, out of many, of these votes. Seven years has been long enough. Now, Hall seeks twelve years in office; and, if re-elected in June, he will be a term-limited lame duck, not needing to care about local values because he will never again be up for re-election. One can only imagine how he will betray us once he is freed from the constraints of the electorate. We can't give him that chance. We must elect a new Senator, one who truly shows our values through his actions and votes.

## **SB 1591**     **Allowing Illegal Aliens Invaders to Obtain an Oklahoma Driver's License.**

Hall voted to give Oklahoma driver's licenses to illegal aliens. Sponsored by a liberal immigration attorney from the south side of Oklahoma City, this bill incentivizes illegal aliens to cross America's borders by rewarding them with an official Oklahoma legal identity. It opens the possibility of more voter fraud and potentially aids the ever-more-powerful illegal cartels and drug pushers with access to the banking system. *SB1591 (2022)*

## **SB 623**     **Silencing Christian Counselors and Taking Away Their License to Practice**

Not just once — but twice — Hall voted for SB 623, sponsored by a liberal Democrat from Tulsa. It would align Oklahoma social-worker licensing standards with national woke activist groups.

Had that law been signed by the Governor, if a Christian social worker — including those serving in our schools — refused to embrace progressive “gender-affirming” ideology or provided counseling consistent with biblical teaching on sexuality, these liberal organizations could brand them “unethical” and the state could censure them or even yank their license to practice, basically putting them out of a job.

When woke was at it's high point, and push came to shove, Hall didn't protect Christian counselors — he would have empowered the radicals working to silence them. This type of assault on people of faith, depriving them of their occupation, is something one would expect in Soviet Russia or communist China, not the United States of America. *SB623 (2019)*

## **SB 1620**     **Putting the Orwellian Police Surveillance State on Steroids**

Hall was one of just 13 senators to vote for authorizing license-plate scanners — Orwellian, real-time government surveillance on steroids. These scanners are often deployed through sole-source contracts, complete with hacking and data-theft vulnerabilities, and raise serious constitutional

concerns. Once the courts rule, their unlawful use has the potential to overturn criminal convictions — re-victimizing Oklahoma crime victims all over again. These scanners routinely exclude immigration enforcement access, creating unconstitutional surveillance of law-abiding citizens while letting illegal border violators off the hook for their crime. *SB1620 (2024)*

**SB 13X** **Authorizing Millions in Corporate Welfare to OKC Billionaires.**

Hall co-sponsored the giving of millions of taxpayer dollars to the Oklahoma City Thunder even though that organization's valuation has skyrocketed to over a billion dollars while being subsidized by the state. It clearly does not need our taxpayer dollars and is just one small example out of many, authored or co-authored by Hall, of corporate welfare giveaways; giving millions those who need it the least. *SB13X (2023)*

**HB 1712** **Making Every Oklahoma Road Into a Toll Road.**

Hall voted for the “Road User Charge Pilot” — a scheme to turn every road into a toll road by using Orwellian technology to track every mile you drive and then send you the bill. This program wasted millions in taxpayer dollars, and the reckless spending alone is nearly as outrageous as the plan itself. But it gets worse: after the pilot ended, domain pirates representing offshore gambling interests took over the program’s publicly promoted website — the same URL the state urged participants to use as they coordinated their participation with state officials — creating serious security and privacy risks for the Oklahomans who trusted that system. *HB1712 (2021)*

**SB 112** **Siding With Murderers — Not Families**

In 2019 — as the social-justice movement climbed towards its peak — Hall stood with a liberal Oklahoma City Democrat and voted to eliminate *life-without-parole* sentencing for juvenile murderers. His vote would have stripped judges and juries of the authority they need to lock up violent offenders who take a life. Instead of standing with victims, Hall sided with the soft-on-crime activists pushing leniency for those who commit the most brutal crimes. It’s no wonder, that now, as potentially evidenced by a recent Stillwater case, leftist-minded judges have the green light to go soft on juvenile criminals. *SB112 (2019)*

**HB 2147** **Allowing City Government to Foreclose on Private Property**

Breaking with long-standing protections that once kept city governments in check, Hall voted to let them **foreclose on and seize private property**. His vote encourages cities to target landowners through code enforcement — turning minor issues into a pretext to take property. *HB 2147 (2025)*
